CONDITIONS OF MEMBERSHIP

1. Membership of the Club is conditional upon the observance of the Club Rules. Members and their guests shall observe any regulations for the use of the facilities posted in the Club and which may be added to and varied from time to time.
2. The Membership subscription shall be fixed by the Club committee and shall be payable annually in advance. The subscription may be varied by the Club committee from time to time, and members shall be notified of any variations in the subscriptions prior to the date of the annual renewal.
3. Persons wishing to become members of the Club, shall complete an official application form, and submit their form to the Director of Golf.
4. Membership shall be renewed by payment to the Club of the annual subscription in force at that time and before the date specified on the invoice.
5. A member is entitled to use the facilities of the Club during the times posted in the Club, providing always that the Club may at any time withdraw all or any part of such facilities for any period or periods where the same are required for use by the Club, or it's guests or in connection with any repair, operation or maintenance work to the facilities or to the Club.
6. The Club reserves the right to refuse admission and/or cancel membership forthwith if any member shall in the opinion of the Club cause nuisance or annoyance to other Club members or members of staff or to other users of the Club facilities.
7. Members and guests must at all times conduct themselves in an orderly and polite manner.
8. Membership badges must be displayed at all times, otherwise green fees must be paid before playing.
9. By their membership, members accept and agree to be bound by the rules of the club
Members will be required to comply with any reasonable directions which the Director of Golf may give to ensure the smooth operation of the Club, the use of the facilities and for the convenience of the members.
10. Any member, or guest, using the Golf Course or any other Club facilities do so at their own risk.
11. No responsibility will be accepted by The Committee for any personal injuries, damage or loss of possessions incurred whilst on the Club property.
